

# WHERE ARE WE: WITH RESPECT TO THE ECONOMY

- Planning and pressure towards a digital currency
- WEF arguing CBDC(Central Bank Digital Currency) will stabilize global financial markets

#### BILL C-27 PREAMBLE

Whereas trust in the digital and data-driven economy is key to ensuring its growth and fostering a more inclusive and prosperous Canada;

Whereas the design, development and deployment of artificial intelligence systems across provincial and international borders should be consistent with national and international standards to protect individuals from potential harm;

Whereas the modernization of national standards for privacy protection to align them with international standards

### **BILL C-27 - DEFINITION**

"artificial intelligence system" means a technological system that, autonomously or partly autonomously, processes data related to human activities through the use of a genetic algorithm, a neural network, machine learning or another technique in order to generate content or make decisions, recommendations or predictions.

### BILL C-27

Disclosure of information to foreign state

- s. 120 (1) Subject to subsection (3), the **Commissioner may**, in accordance with any procedure established under paragraph (4)(b), **disclose information** referred to in subsection (2), other than information the Commissioner has received under section 10 or paragraph 110(1)(e), that has come to the Commissioner's knowledge as a result of the exercise of any of the Commissioner's powers or the performance of any of the Commissioner's duties and functions under this Act **to any person or body** who, under the legislation of a foreign state, has
- (a) powers, duties and functions similar to those of the Commissioner with respect to the protection of personal information; or
- (b) responsibilities that relate to conduct that is substantially similar to conduct that would be in contravention of this Act.

### BILL C-27


automated decision system means any technology that assists or replaces the judgment of human decisionmakers through the use of a rules-based system, regression analysis, predictive analytics, machine learning, deep learning, a neural network or other technique.

#### Authorized representatives

s. 4 The rights and recourses provided under this Act may be exercised (a) on behalf of a minor by a parent, guardian or tutor, unless the minor wishes to personally exercise those rights and recourses and is capable of doing so;

#### Purpose

s.5 The purpose of this Act is to establish — in an era in which data is constantly flowing across borders and geographical boundaries and significant economic activity relies on the analysis, circulation and exchange of personal information

# WHERE ARE WE: WITH RESPECT TO LAND

- Bill C15 requires Canada to comply with the United Nations Declaration for the Right of Indigenous Persons ("UNDRIP")
- UNDRIP Article 26 indigenous claim the land
- Crown Land will have new owners
- Happening in B.C. and N.B.
- Worldwide push by the U.N.
- Once the indigenous have succeeded in their land claims there will be a further transition to the people of the world
- You will own nothing and be happy

### **BILL C-15 UNDRIP**

### Purpose:

- s.4 The purpose of this Act is to:
- (a) affirm the Declaration as a universal international human rights instrument with application in Canadian law; and
- (b) provide a framework for the Government of Canada's implementation of the Declaration.

### BILL C-15

### Consistency:

s. 5 The Government of Canada **must**, in consultation and cooperation with Indigenous peoples, **take all** measures necessary to ensure that the laws of Canada are consistent with the Declaration.

#### Action Plan:

s. 6 (1) The Minister **must**, in consultation and cooperation with Indigenous peoples and with other federal ministers, **prepare and implement** an action plan to achieve the objectives of the Declaration

### UNDRIP- UNITED NATIONS DECLARATION ON THE RIGHTS OF INDIGENOUS PEOPLE

#### Article 26:

- 1. Indigenous peoples have the right to the lands, territories and resources which they have traditionally **owned**, **occupied or otherwise used or acquired**.
- 2. Indigenous peoples have the right to own, use, develop and control the lands, territories and resources that they possess by reason of traditional ownership or other traditional occupation or use, as well as those which they have otherwise acquired.
- 3. States shall give legal recognition and protection to these lands, territories and resources. Such recognition shall be conducted with due respect to the customs, traditions and land tenure systems of the indigenous peoples concerned.

### **UNDRIP**

#### Article 28:


- 1. Indigenous peoples have the **right to redress**, by means that can include **restitution** or, when this is not possible, **just, fair and equitable compensation**, for the lands, territories and resources which they have traditionally **owned or otherwise occupied or used**, and which have been confiscated, taken, occupied, used or damaged without their free, prior and informed consent.
- 2. Unless otherwise freely agreed upon by the peoples concerned, compensation shall take the form of lands, territories and resources equal in quality, size and legal status or of monetary compensation or other appropriate redress.

### INDIGENOUS DEFINED: S.35(2) CONSTITUTION ACT 1982

- \*Definition of aboriginal peoples of Canada
- •(2) In this Act, aboriginal peoples of Canada includes the Indian, Inuit and Métis peoples of Canada.




# AN ACT TO AMEND THE BROADCASTING ACT s.3(3)(iii) through its programming and the employment opportunities arising out of its operations, serve the



#### Purpose:

s. 4 The purpose of this Act is to regulate digital news intermediaries with a view to enhancing **fairness** in the Canadian digital news marketplace and contributing to its sustainability, including the sustainability of news businesses in Canada, in both the non-profit and for profits sectors, including independent local ones.

  - 40,000 excess death in Canada
  - 42,000 excess deaths in Australia
  - 54,000 excess deaths in the U.K.
  - 103,000 excess deaths in Germany
  - 300,000 excess deaths in the U.S.
  - Cause vaccine, suicide, opioid overdose








### TRUST


For decades we trusted our politicians and governments to act in our best interests.

### THE SWAMP



### "LETS" – LOCAL EXCHANGE TRADING SYSTEMS

### What Are Local Exchange Trading Systems?

Local Exchange Trading Systems (LETS) are locally organized, economic organizations that allow the exchange of goods and services among group members. The groups use a locally created units of value as currency which can be traded or <a href="mailto:bartered">bartered</a> in exchange for goods or services. Members of LETS typically view the systems as organized and cooperative schemes that maximize purchasing power while benefiting members and the community.

#### **KEY TAKEAWAYS**

- •Local Exchange Trading Systems are a type of bartering system in local communities.
- •The LETS movement reached its height in the 1990s.
- •The movement is based on five key governing principals: cost of service, consent, disclosure, equivalence to the regional currency, and interest-free credit.








#### HEALTH PROFESSIONS ACT

#### College established


- 2 A college is a corporation that
  - (a) is created or continued in a schedule to this Act,
  - (b) consists of its regulated members and other members, and
  - (c) has the capacity and, subject to this Act, the rights, powers and privileges of a natural person.

<u>1999 cH-5</u>.5 s2

#### College's role 3(1) A college

- (a) must carry out its activities and govern its regulated members in a manner that protects and serves the public interest,
  - (b) must provide direction to and regulate the practice of the regulated profession by its regulated members,
- (c) must establish, maintain and enforce standards for registration and of continuing competence and standards of practice of the regulated profession,
  - (d) must establish, maintain and enforce a code of ethics,
- (e) carry on the activities of the college and perform other duties and functions by the exercise of the powers conferred by this Act, and
  - (f) may approve programs of study and education courses for the purposes of registration requirements.
- (2) A college may not set professional fees, provide guidelines for professional fees or negotiate professional fees on behalf of some or all of its regulated members unless the Minister grants the college an approval under section 27.
- (3) A college or a council or committee of a college may not be a certified bargaining agent as defined in the <u>Labour Relations</u>
